Triangle Federal Credit Union proudly honored John Gibbons, Jr. with his induction into the Triangle FCU Hall of Fame during the 66th Annual Meeting on March 24, 2026. This distinguished recognition celebrates individuals whose leadership, service, and unwavering dedication have made a lasting and meaningful impact on our credit union and the members we serve.

Mr. Gibbons served as President/CEO of Triangle FCU from January 1, 1987, until his retirement on December 31, 2024. Over his remarkable 38-year tenure, he guided the credit union through sustained growth and transformation. Under his leadership, assets increased from \$10 million to more than \$110 million, a testament to his commitment to responsible expansion, financial strength, and exceptional member service. He championed the evolution of Triangle FCU from one location to five branches across the Golden Triangle and oversaw significant technological advancements that modernized operations and elevated the member experience.

In May 2024, Mr. Gibbons was also inducted into the Mississippi Credit Union Hall of Fame, recognizing his decades-long dedication to the credit union movement and his influence beyond our own institution.
